The meeting was called to order and a roll call was taken.

APPROVAL OF THE MINUTES:

1. Regular BOT Meeting, May 16, 2023

A **Motion** was made by Trustee Donna Vegter, seconded by Trustee Larry Nice, Sr., to approve the Regular Meeting Minutes dated May 16, 2023, as presented. President Jacobs called for a voice vote. All in favor. Motion carried.

APPROVAL OF THE BILLS:

1. Board/Expenditure Report

A **Motion** was made by Trustee Michael Minogue, seconded by Trustee Justin Lohrens, to authorize payment of the Fire Service and Ambulance Fund bills, totaling \$199,969.43, as presented. 1. **Personnel** – [Jacobs & Vegter]

Chief Fierce reported the following:

- Obtaining quotes for some Capital projects, such as, roof repairs and bay floors.
