ORDINANCE NO. 206

AN ORDINANCE ESTABLISHING FUND BALANCE DESIGNATIONS FOR THE FRANKFORT FIRE PROTECTION DISTRICT, WILL COUNTY, ILLINOIS

WHEREAS, the Board of Trustees of Frankfort Fire Protection District, Will County, Illinois (the "District"), have adopted a fund balance policy; and

WHEREAS, the Board of Trustees of the District deem that is appropriate to designate certain fund balances as Committed for specific purposes; and

WHEREAS, the Board of Trustees of the District intend to create a Capital Project Fund for the purpose of accumulating and expending funds for vehicle replacement.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE FRANKFORT FIRE PROTECTION DISTRICT, WILL COUNTY, ILLINOIS, AS FOLLOWS:

<u>Section 1.</u> The fund balance of the Frankfort Fire Protection District designated in this Ordinance is committed for the specific purpose indicated. Amendments or modifications of the committed fund balances set forth herein shall require formal action by the Board of Trustees.

Section 2. \$2,375,000 of the District's May 31, 2014 general fund balance is considered committed for transfer to the Vehicle Replacement Fund.

<u>Section 3.</u> If any word, phrase, clause, sentence, paragraph or section of this Ordinance shall, for any reason, be held invalid, such invalidity shall not affect the validity of the remaining words, phrases, clauses, sentences, paragraphs, sections or the remaining portions of this Ordinance.

<u>Section 4.</u> This Ordinance shall be in full force from and after its adoption and publication, as provided by law.
